Approval of Last Meetings Minutes – Kitren Fischer Moved, Jennifer Burrill Seconded

Vice Chair Nomination – Discussed having someone from the County.

Three pending nominations were Kitren Fischer, Judge Rysanke, and Morgan Wood.

Jennifer Romero and Alex Dominguez nominated Mark Boschelli from the Detention Center. Both Julie Ball and Judge Marlowe Sommer spoke highly of him from their interaction with him at the Mental Health Summit. Alex Dominguez said he would be meeting with Rachel O’Conner from the County later in the afternoon and would talk to her about him potentially being Vice Chair. Judge Marlowe Sommer said he was asked at the Summit to consider the role and he said he was extremely busy. The County members said he’s really the one that is in the middle of the changes the County is making for re-entry of familiar faces. We will decide the Vice Chair at the next meeting.

Smarter Sentencing – All are onboard to pursue having someone from the National CJCC come out to Santa Fe and teach the “Smarter Sentencing” course. Kateri will be asked to coordinate the sharing of costs within or further beyond the First Judicial District, including stakeholders that will share in the costs. Hotel and airfare is also part of the package. We want to do this no later than Spring 2023 if we can.

Behavioral Health Summit – Judge Marlowe shared her disappointment that the District Attorney’s office was not present at the Summit, except for a visit from Douglas Wood on Tuesday afternoon, and a visit from Morgan Wood on Wednesday morning, for around 45 minutes. Judge Marlowe Sommer was appreciate of the effort of these two ADA’s.

Split into Subcommittees – All attendees did agree to have the monthly meetings in-person in Judge Marlowe Sommer’s courtroom, Followed by the break-out into subcommittees. She will send out one more solicitation for committee assignment before assigning those that have given no input into a subcommittee.
