3. Committee Updates:

Rio Arriba – SIM Mapping workshop in September, at the conclusion we set up subcommittees to further the goals that were established there. Four goals: Detox, Supportive Housing, Crisis Response Team, and Expansion of Peer Support within the County.

Santa Fe – Sim Mapping held just this past Thursday had over 80 participants held over one day. Reports are forthcoming.

4. AOT UPDATE:

Rachel O'Connor: Would like to know who has been participating in AOT, AOC approved funding for AOT including First Judicial District. There has been a group including many of the people in the room to discuss what the planning will look like in this District. There are a couple of counties that have already started including in Dona Ana County. Categories of services are Case management IOC ACTTS. To assist those who are coming with integrating back into the community to help them be successful. Can include many different services including vocational, testing, behavioral health, counseling and other services. AOC beginning to move toward implementation. There are specific criteria and we can send out an outline regarding the programming.

We would like to have AOC present on AOT

5. Health Care Authority on Re-entry Medicaid Waiver

State is in the early stages of implementation of the Medicaid Waiver. Rachel wants to make sure there is an awareness of the covered programming. Services: Physical and Behavior post release case management MAT 30 supply of meds diagnostics including lab and radiology medical equipment family planning peer support hep c treatment and clinical consult for physical and behavioral health needs.

Would like to have Medicaid present at next meeting to discuss plans for roll out.

6. Additional Announcements

About ten members of the CJCC toured the Bernalillo County Reentry Center. It is cutting edge in terms of the services provided, cases management, housing, treatment, legal services, medical care.

Comments: Mark Boschelli – the SFCDC liked it so much we are hoping to incorporate the design into the Jail.

Santa Fe County – Ongoing funding for the ENGAGE Program for Law Enforcement Assisted Diversion

- Elizabeth Peterson: As a result we are going to contract with a case manager and open referrals to the DA and the LOPD
 - o Potential to have ENGAGE present to Group
- Received funding for PMS to do healthcare with those leaving the Jail.
 - o Trying to find immediate medical care is difficult for those leaving the Jail.
 - o Mark – Hiring a community health worker and a peer to be located at the jail to drive those re-entering to their appointment directly from the jail to the service.

Julie Ball would like to have AOC present on Competency Diversion

Strategic Planning

Each County will have their own plan which will relate to the whole CJCC's overarching plan.

Jamie Goldberg from the NMSC Update on Grant Items: Planning for upcoming fiscal year. 5 Million dollar request to the legislature. Applications open through March. One major change, opening grants to juvenile grants as well which were not previously offered. Less emphasis on out of state travel and more on immediate effect grants. April 29th and 30th for the CJCC Convening. 1-3 Members will be allowed per CJCC.
