Judge Marlowe thanked Kateri and Rachel O'Connor for their work on the RFP.

Kitren: Question on how many hours the RFP will be for?

Kateri: Goal is for it to be a full time position.

- **Grant Proposals for the Spring Session**

Krossroads: Decided to forgo submission of application this funding cycle and will look forward to October instead.

Question re: Bus Pass grant renewal

- Bus passes are not being utilized as much as we expected and most that are using it are not renewing it
- Can the passes be donated if they have already been purchased?
 - o Kateri would have to look into how we purchased the passes and whether the grant would allow for that but doesn't think so.

Pretrial Peer Support Rio Arriba: RACJCC requested two years of funding last year for the purposes and assigning a certified peer support worker. Received funding for one year of peer support and was able to hire Ms. Anaya in December. Ms. Anaya has 14 clients. Was instructed to reapply for second year of funding. Asking for approval to apply for the second year of funding.

Judge Marlowe Question: Does she coordinate pretrial services for them?

- Judge Lidyard: If it's an individual who has been assigned to both pretrial and to Ms. Anaya she assists with those obligations but she also has individuals who are not assigned to pretrial services.

Judge Marlowe Question: Do you have good numbers on appearances and picking up new crimes?

- Judge Lidyard: Yes. I don't believe a single one of the 14 individuals has picked up a new crime.

Sixto Aguirre: Cruz works really well with her clients and they enjoy working with her. Wants the grant to continue.

Mona Serna: Has observed Ms. Anaya work with her clients and has seen her connect clients with services and thinks she is doing great work and her clients are responding well to her.

Cruz Anaya: Clients have maintained constant contact with her and she feels clients work well with her because they can relate to her and they are being connected with the services they need.
